Applicants' certification for installation of a tent

1. I certify that the tent is made of flame resistant fabric and a Certificate of Flame Retardance is provided and the Certificate matches the label on the tent in accordance with NFPA 1-25.2.3.1, 101-11.11.2.1 and 101-11.11.2.2.
2. I certify the tent stakes provide a minimum of 10' distance o.c. in accordance with NFPA 1-25.2.5.3; 25.1.6.4 and 101-11.11.3.1.
3. I certify a layout of the use of the tent has been provided with this application in accordance with NFPA 1-3.2.2.
4. I certify a minimum of two (2) approved 2A:10BC fire extinguishers will be provided at opposite ends/sides of the tent. Portable fire extinguishers will be provided as applicable with the hazard in accordance with NFPA 1-25.2.5, 1-3.2.2, and 101-11.11.5. (Size of tent may require additional fire extinguishers).
5. I certify **NO** generators or flammable products (gasoline, oil, etc.) shall be stored/kept under the tent. Any portable generator shall be a minimum of 5' from the tent and protected in accordance with NFPA 1-25.1.12.1 and 101-11.11.4.1.
6. I certify all electric shall comply with NFPA 70.
7. I certify the ground enclosed by the tent and an additional 10' around the perimeter will be cleared of all combustable and flammable materials or vegetation prior to erection of the tent in accordance with NFPA 1-25.1.5.2 and 101-11.11.4.1.
8. I certify **NO SMOKING** signs will be provided and visible from all areas of the tent in accordance with NFPA 1-25.2.4.2 and 101-11.11.4.2.
9. I certify **EXIT** signs will be provided and visible from all areas of the tent and a 44" clear path to each exit, so as to permit unobstructed egress from any location within the tent (based on the size of the tent) at the fire departments direction in accordance with NFPA 1-3.2.2. If the tent is open to the public after sunset, EXIT signs will be illuminated and the tent will have emergency lighting.

Application is hereby made to obtain a permit to do the work and installations as indicated. I certify that no work or installation has commenced prior to the issuance of a permit and that all work will be performed to meet the standards of all laws regulating construction in this jurisdiction.

I understand that a separate permit must be secured for ELECTRICAL WORK, PLUMBING WORK, SIGNS, HEATERS, AIR CONDITIONERS, ETC.

OWNER'S AFFIDAVIT: I certify that all of the foregoing information is accurate and that all work will be done in compliance with all applicable laws regulating construction and zoning.

OWNER'S ELECTRONIC SUBMISSION OF STATEMENT: Under penalty of perjury, I declare that all the information contained in this tent permit application is true and correct.

Building Permit Applications shall be submitted on paper and PDF format/ CD, for review and contain all the items listed. For tents, copies of a plot plan and base diagram plus tie down diagram with manufacturers name and model number must accompany application. In addition, plumbing, electrical, mechanical and environmental plans shall be submitted to secure these permits, when applicable. The tent permit fee is based on a \$40.00 fee, plus additional fees for electrical, plumbing and mechanical if applicable.

Application is valid for 180 days.

Permit expires after 6 months. Permit fee is non-refundable.

Contractors must maintain, State License, PCCLB License, General Liability and Workman's Compensation Insurance.

Canopy / Tent Permit Application Checklist

Tent Permit Application

- o Need to state the date(s) the canopy is being put up and taken down

Electrical Permit Application (if applicable)

Plans to be submitted (2 sets each):

- o Drawings showing tie-downs and wind load for canopy
- o Plan showing means of egress for tent, exit signs and lighting
- o Site plan showing location of tent(s)

Additional documents to be submitted:

- o A certified copy of the Recorded Notice of Commencement is required if contract is greater than \$2,500 (required if canopy is permanent)
- o Copy of contract
- o Copy of Temporary Use Permit approval (a separate Temporary Use Permit must be obtained; issued by Department of Planning and Redevelopment)
- o Fire Retardant Certificate
- o Plans and specifications must also be submitted as a PDF file if document size exceeds 11 inches by 17 inches in size

Contractor/subcontractor must be currently registered in the City of Oldsmar.

All signatures must be notarized for contracts of \$2,500 or more.

Inspections Required

- o Final building
- o Final electric (if installed)
- o Final fire
