Chapter 50 SECONDHAND GOODS

Sec. 50-31. Defined.

The phrase “garage sale,” when used in this article, means and includes a carport, garage or yard sale, and shall be defined to include but not limited to the following:

- (1) Any sale in which the person having or conducting the sale does not have an occupational license for retail sales and the sale takes place on private residential premises;
- (2) A sale of short duration, of goods and personal items belonging to a person, members of his family or immediate neighbors, such sale taking place on the premises of the person owning all or a portion of the merchandise and located in a residential zone;
- (3) A sale of which the taking of orders for any item shall be prohibited and the sale shall be limited to only the sale of items actually located on the premises.

Sec. 50-32. Signs.

A maximum of four signs may be employed in conjunction with a garage sale and shall be located as follows: one sign at the site of the sale and three signs located at points of strategic directional need, such locations to be designated on the permit. Signs shall not exceed three square feet in area, and the permit number and the dates of the authorized sale shall be lettered on the back of the sign for purposes of inspection. All such signs shall be removed within 24 hours after the expiration of the permit and each day that such signs are allowed to remain shall constitute a separate offense.

NOTE: NO SIGNS ARE PERMITTED TO BE PLACED ON ANY RIGHT-OF-WAYS.

Sec. 50-51. Required.

A permit is required for all garage sales conducted in residentially zoned areas within the city.

Sec. 50-53. Limitation on number issued at one location.

The number of garage sale permits shall be limited to four sales per year at one location. For the purposes of the garage sale permit; the location shall be the premises at which the sale is conducted and which is occupied by the person conducting the sale of who owns the goods or by members of his immediate family.

Sec. 50-54. Duration.

All garage sale permits shall be for a maximum period of ten consecutive days and the authorized dates shall be reflected on the face of the permit.

Sec. 50-55. Display.

The garage sale permit shall be displayed on the premises at all times during the garage sale.
