## **ORDINANCE NO. 2016-08**

AN ORDINANCE OF THE CITY OF OLDSMAR AMENDING SECTION 70-268 OF THE CODE OF ORDINANCES TO DECREASE THE SIGNIFICANT INDUSTRIAL USER (SIU) AND INCREASE THE CATEGORICAL INDUSTRIAL **USER** (CIU) WASTEWATER DISCHARGE PERMIT FEE; AMENDING SECTION 70-295 TO PROVIDE FOR A 3% INCREASE OVER THE NEXT 4 FISCAL YEARS THE MONTHLY SERVICE AVAILABILITY CHARGE **RECLAIMED WATER: AMENDING SECTION 70-444 TO PROVIDE** FOR A 3% INCREASE OVER THE NEXT 4 FISCAL YEARS TO THE SERVICE MONTHLY SERVICE **CHARGES** CONSUMPTION RATES: TO PROVIDE FOR A 3% INCREASE OVER THE NEXT 4 FISCAL YEARS TO THE IRRIGATION OR PROCESS WATER RATES: AMENDING SECTION 70-445 TO PROVIDE FOR A 3% INCREASE OVER THE NEXT 4 FISCAL YEARS TO THE SEWER SERVICE MONTHLY SERVICE CHARGES AND CONSUMPTION RATES: AMENDING SECTION 70-447 TO PROVIDE FOR A ONE-TIME INCREASE FOR MISCELLANEOUS SERVICE CHARGES, INCLUDING DELINQUENT WATER TURN OFF, WATER TURN ON AFTER HOURS, METER RE-READ, WATER TURN ON AND WATER TURN OFF; AMENDING SECTION 70-448 TO REVISE THE CHARGE FOR METER REMOVAL. TESTING AND REPLACEMENT FROM \$50.00 TO THE CITY'S ACTUAL COST OF REMOVAL, TEST AND REPLACEMENT, TO INCREASE THE FIRE HYDRANT CHARGE TO \$95.00 PER YEAR FOR EACH HYDRANT ON PRIVATE PROPERTY, AND TO INCREASE THE FIRE HYDRANT CHARGE TO \$110.00 PER YEAR FOR EACH HYDRANT ON PRIVATE PROPERTY OUTSIDE THE CITY'S FIRE PROTECTION SERVICE AREA; AMENDING SECTION 70-450 TO PROVIDE FOR A ONE-TIME INCREASE TO WATER AND SEWER CONNECTIONS FEES AND TO ESTABLISH A NEW FEE FOR CONNECTION INSTALLED BY DEVELOPER FOR METERS LARGER THAN THREE INCHES AT THE ACTUAL COST PLUS TEN PERCENT: AMENDING SECTION 70-451 TO PROVIDE FOR A ONE-TIME INCREASE TO METER INSTALLATION FEES; CREATING SECTION 70-453 TO PROVIDE FOR PRIVATE LIFT STATION PERMIT AND INSPECTION FEES AND RE-INSPECTION FEES; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF.
